

Directions to the Alfred M. Brown Operation Center, 850 Warren Coleman Blvd Concord, North Carolina

From Columbia: Take I-77 North through Charlotte to I-85, take I-85 North to Greensboro. Take exit 58 which is Hwy 29/601 Concord/Monroe. Follow 29/601 (Concord Parkway) 3.5 miles to Hwy 601 bypass (Warren C. Coleman Blvd.). Go 2.5 miles on Hwy 601 bypass to intersection of Hwy 601 and Manor Ave. Turn right into entrance road to the Alfred M. Brown Operation Center.

From Albemarle: Take Hwy 73 West to Hwy 49 South to Concord/Charlotte, Hwy 49 to Hwy 601 North to Concord. Travel 1 mile to intersection of Hwy 601 and Manor Ave. Turn left at light into entrance road to Alfred M. Brown Operation Center.

From Greensboro: Take I-85 South to exit 58 which is Hwy 29/601 Concord/Monroe. Follow Hwy 29/601 (Concord Parkway) 3.5 miles to Hwy 601 bypass (Warren C. Coleman Blvd.). Go 2.5 miles on Hwy 601 bypass to intersection of Hwy 601 and Manor Ave. Turn right into entrance road to the Alfred M. Brown Operation Center.
